  - o A minimum of two similar completed works costing not less than **Rs. 74 lakh** each.
  - o A minimum of one similar completed work costing not less than **Rs. 98 lakh**.
- 3. Minimum average annual turnover of **Rs. 123 lakh** calculated as total certified payments received for contracts in progress or completed, within the last **three** years.
- 4. Financial Resource Requirement/Working Capital requirement of **Rs. 98 lakh** for the subjected Contract package. Total Financial Resource Requirement shall be **Rs. 98** lakh plus requirement for current contract commitment as in FIN-4 of Section 4 of the Bidding Document.
