

In continuation of this office Notification No.G.25019/4/13 – PWD dt. 26.3.2014 regarding application of CPWD Manual Section 20 and to eliminate competition among present contractors to get contract works under Public Works Department at any cost quoting rates much below present market rates/SOR rates, which leads to substandard quality of works and contractors abandoning works at various locations resulting in :

This is circulated in the best interest of works and public service.

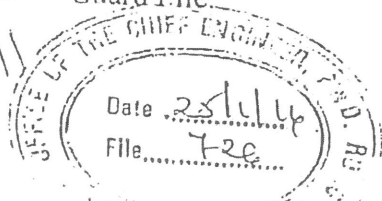
